## 2010 Discipline Data Validation

- Includes: 7 basic indicators plus 2 report only indicators.
- Evaluates: All school districts and charters (except charters are not included in Indicator #2, #3 and #9).
- Uses: Data from the 2007-2008, 2008-2009, and 2009-2010 PEIMS Summer/Submission 3 (425 Record).

**278 districts**<sup>1</sup> districts were identified under the seven basic indicators. Report Only (RO) indicators do not require an intervention until such time as they become "live" indicators, usually after a period of two years.
