Veteran Affair and Military Installations Committee Recommended Interim Charges October 11, 2013

- 1. Study the impact of military installations on local communities including the economic impact to local businesses, government services, housing, infrastructure, law enforcement, and quality of life issues. Identify statutory or regulatory obstacles in these communities and make recommendations for improvement.
- 2. Review the current statutory and regulatory requirements for Veteran County Service Officers to include minimum county veteran population, appointment, position qualifications, duties, training, organizational structure, and reporting. Make recommendations for improving services to military veterans, their families, and survivors delivered by Veteran County Service Officers.
- 3. Review methods for improving employment opportunities for veterans at state agencies, including institutions of higher education. Examine current hiring preferences, enforcement, and reporting related to disabled veterans and veterans. Make recommendations for improving the hiring of disabled and non-disabled veterans state agencies, including institutions of higher education.
- 4. Study methods that allow veterans, their families, and survivors to efficiently access services provided by non-profit organizations around the state. Examine the effectiveness, standards, and consistency of the 2-1-1 information and referral system for military and veteran families statewide. Make recommendations for improving access to non-profit organizations providing services to military, veterans, their families, and survivors.
- 5. Examine the condition of Texas National Guard (TxNG) facilities and infrastructure. Review the impact of facilities and infrastructure on the ability of the Texas Military Department to ensure the safety of service members, readiness, and ability to respond to natural disasters. Make recommendations for best practices, including funding options, to ensure compliance with health and safety code, gender-equal facilities, and Americans with Disability Act building requirements, as well as ensuring technological needs are met.
- 6. Research methods to prevent the abuse of controlled substances by investigating the ability for physicians not licensed in Texas but practicing through the Department of Defense to participate in the online drug monitoring program "Prescription Access in Texas."

- 7. Review Veteran Homes operated by the General Land Office. Research the locations, capacity, and quality of care provided to veterans and other residents. Make recommendations for expanding access and improving Veteran Homes.
- 8. Monitor the implementation of legislation addressed by the Senate Committee on Veteran Affairs & Military Installations, 83rd Legislature, Regular and Called Sessions, and make recommendations for any legislation needed to improve, enhance, and/or complete implementation. Specifically, monitor the following:
 - Peer-to-Peer Mental Health Program administered by the Health and Human Services Commission.
 - Hazlewood Act and other veteran-related legislation effecting institutions of higher education.
 - College Credit for Heroes operated by the Texas Workforce Commission.
 - State effort to reduce the backlog of compensation and pension claims at the US Department of Veterans Affairs.
 - Occupational licenses for active duty service members, veterans, and their families.
 - Entrepreneurship programs for veterans.
 - Other veteran-related legislation as determined by the VAMI Committee.
