Redistricting Restores Historic Community of Interest

The redistricting plan passed by the 87th Texas Legislature substantially changes Senate District (SD) 21, represented by Senator Judith Zaffirini, D-Laredo. When new data are released by the U.S. Census Bureau every 10 years, the Legislature draws Texas Senate, Texas House of Representatives, Congressional and State Board of Education districts through a redistricting legislative process. Texas’ population increased by more than 4 million since 2010. Since 2012 SD 21 has included

18 counties—13 completely and 5 partially. After January, 2023, the district includes 16 by removing Atascosa, Bee and San Patricio counties and by adding Dimmit County. It also contains greater portions of southeast Travis County, including Austin-Bergstrom International Airport, and Hays County, including all of Kyle and San Marcos.

“I am honored to have served many longtime friends and constituents in SD 21,” Senator Zaffirini said. “Count on me to

continue to champion issues that benefit not only my constituents, but also Texans throughout the state.”

Dimmit County had been part of SD 21 for more than a century until it was drawn out in 2012. Returning it to the district reunites a historic community of interest with six other counties, namely, Duval, Jim Hogg, La Salle, Starr, Webb and Zapata, that have been together for more than 100 years.

SD 21 will stretch more than 360 miles from Travis County in the north to Starr County in the south, and more than 200 miles from the Rio Grande in the west to Caldwell County in the east—until the next redistricting cycle in 2031.

“I’m delighted to see these communities come together in the spirit of collaboration with a common purpose,” Senator Zaffirini said, “and look forward to working harder than ever on their behalf in the Texas Senate.”

Senator Zaffirini Champions Education, Health Care Access

“Access to affordable education and health care are the most important factors for the next generation of Texans being healthy and successful,” Senator Judith Zaffirini said. “Though each year presents new challenges, we remain focused on securing these critical services.”

A former educator with 13 years of teaching experience, she understands the Legislature’s role in providing learning opportunities for students at every level. This includes increasing participation in early childhood education programs, supporting current and retired teachers and administrators and maintaining a standard of excellence for Texas colleges and universities.

“A quality early education leads to better outcomes throughout a student’s academic career and increases the likelihood that the student will be graduated from a higher learning institution,” Senator Zaffirini said.

Her higher education priorities include reducing the crushing burden of student loan debt, eliminating barriers to college and

modernizing financial aid. “Our institutions should empower our students not only to learn, but also to excel and to thrive,” she said.

Equally important is access to health care. Senator Zaffirini believes strongly that health care is a right that should be afforded to all, not a privilege reserved for the few.

“Expanding health care resources would allow more Texans to live longer, happier and healthier lives,” she said, “including persons in medically underserved areas in Senate District 21.”

Last session she filed Senate Bill 38, which would have expanded Medicaid and given coverage to 1.7 million uninsured Texans. It also would have drawn down more than \$15.3 billion in federal funding.

“Although it did not receive a hearing, my staff and I will file the bill anew for the 88th legislative session,” she said. “It’s the least we can do for our veterans, seniors, persons with disabilities, children and other uninsured persons who deserve basic access to medical care.”

Senator Zaffirini's Appointments

In the time between regular legislative sessions, Senate committees invite advocates, agency leaders, subject matter experts, and community members to testify at public hearings. Insight gathered is necessary to developing recommendations for the Legislature to address the next session.

Lt. Gov. Dan Patrick appointed Senator Judith Zaffirini during the 87th Legislative Interim to three special committees—the Texas Commission on Special Education Funding, the Special Senate Committee to Protect All Texans and the Joint Committee to Study Abandoned Oil and Gas Wells. She continues to serve on four Senate

standing committees—as Vice Chair of Natural Resources and Economic Development (NRED) and as a member of Higher Education, Local Government (LG), and State Affairs—as well as on the Texas Judicial Council and the Texas Access to Justice Commission.

Standing Committees

Senate Higher Education Committee members are reviewing the Permanent University Fund for The University of Texas at Austin and Texas A&M University, enrollment trends, faculty tenure policies, workforce training programs and U.S. history requirements. Only 20 percent of Senate District (SD) 21 residents have a bachelor's degree or higher, despite the availability of higher education institutions in the district, which limits their earning potential and future opportunities.

"I will continue to work tirelessly to increase accessibility, affordability and excellence in higher education to ensure more students in our district obtain degrees that enable them to enjoy a better quality of life and be more productive and successful," Senator Zaffirini said.

Representing the majority of the Eagle Ford Shale region, she is uniquely positioned to advocate in NRED for balancing industrial interests with responsible environmental stewardship. Committee members are evaluating economic development programs, hotel occupancy taxes, the state's natural gas storage capacity and wildfire control. The committee also will vet Sunset Advisory

A lifelong champion of persons with intellectual and developmental disabilities, she looks forward to assessing the state of special education in Texas, identifying areas for improvement and recommending a new funding structure as a member of the Texas Commission on Special Education Funding.

In the Joint Interim Committee to Study Abandoned Oil and Gas Wells, Senator Zaffirini will use her environmental expertise to develop and implement a strategy to plug approximately 7,000 wells in the state. Unplugged and abandoned oil wells contami-

nate groundwater or leak greenhouse gases, posing serious public health and environmental threats, including in SD 21.

Senator Zaffirini also is part of the Senate Special Committee to Protect All Texans, which is studying school safety, social media, police training, firearm safety and mental health access. The committee was created after a shooter in Uvalde killed 19 students and two teachers at Robb Elementary School. “Because I used to represent Uvalde, represent Sutherland Springs and experienced the UT Tower sniper, I am committed to finding common-sense, bipartisan solutions to prevent mass shootings,” she said.

Judiciary-related Committees

As a member of the Texas Judicial Council and the Texas Access to Justice Commission, Senator Zaffirini helps develop legislation ensuring our court system is fair to all Texans.

During the 88th Legislative Session she will work with judges and lawyers to authorize remote hearings permanently, increase legal aid funding and enhance access to interpreters. “Every Texan should be treated equally in our courts regardless of income, ethnicity, gender or any other characteristic” she said. “I am especially grateful to Lt. Gov. Patrick for these important appointments.”

District Meetings Help Strengthen Community Ties

The legislative interim offers many opportunities for Senator Judith Zaffirini to interact with the families of Senate District (SD) 21 in their home counties.

“Constituent meetings are as engaging as they are informative,” she said. “I hear firsthand accounts of issues throughout the district, connect persons to resources, collaborate regarding potential legislation and more.”

She also gladly meets with Gov. Greg Abbott’s nominees for state boards. “It always is exciting when someone from our district serves at the state level,” she said. “After checking references I meet with every nominee to confirm his or her character, judgment and ability to serve and to discuss our shared priorities for SD 21. I am delighted to sponsor qualified nominees

for confirmation by the Texas Senate. This initial meeting often sets the groundwork for a productive working relationship for years to come.”

Attending festivals, parades and myriad events also provides for a rich variety of venues at which Senator Zaffirini can visit her vibrant district and observe local traditions.

Senator Zaffirini and her staff prioritize responding to and meeting with every constituent who requests an appointment, including virtually via Zoom. This practice enables them to remain responsive, effective and engaged. “This is a mutually beneficial experience,” she said. “I truly encourage anyone who encounters an issue to contact my staff and me for assistance. Our plates are never too full.”

Senator Zaffirini Prioritizes Constituent Services

“*Serviam* (I shall serve.) is our mantra,” Senator Judith Zaffirini says often. “It’s a lesson learned from the Ursuline nuns that reflects our readiness to respond to constituents.” Perhaps the most common way we assist is by guiding them through issues with state agencies. We do our best to expedite these processes and refer persons to appropriate resources.”

In April, 2022, for example, two healthcare providers from Laredo—Gerardo Vargas, owner of South Texas Medical Equipment and Supplies, and Joel Hernandez Jr., owner of Primary Health Source—had technical difficulties revalidating their Medicaid Provider Enrollment statuses.

Without it, these healthcare providers couldn’t help their medically underserved communities. Thankfully, they secured application extensions when Senator Zaffirini and her staff contacted the Health and Human Services Commission.

“It’s important to follow-up with constituents like Mr. Vargas and Mr. Hernandez to ensure their issues are resolved in the short-and long-term,” Senator Zaffirini said.

The senator’s expertise also extends to other agencies, including the Texas Department of Housing and Community Affairs (THDCA).

In September, 2021, Alonso Ramos contacted Senator Zaffirini’s staff for assistance when he learned he could face eviction. She and her staff requested TDHCA expedite Mr. Ramos’ application, and he was approved.

Several months later, in June, 2022, Mr. Ramos missed the deadline to renew his Supplemental Nutrition Assistance Program (SNAP) benefits. “Because Senator Zaffirini and her staff were so effective in processing my application, I knew they also could assist me with my SNAP benefits, too,” Mr. Ramos said.

“We want to make it as easy as possible for Texans to use state-funded social programs,” Senator Zaffirini said, “and are delighted to facilitate their interactions.”

What’s more, these constituent cases often inspire legislation, as was the case when the pandemic forced many Texans to file for unemployment benefits with the Texas Workforce

Commission. Senator Zaffirini passed three bills to improve the agency’s operations.



Senator Zaffirini Honored for Legislative Excellence

A tireless advocate for Texas families, Senator Judith Zaffirini is the second highest-ranking senator and the highest-ranking woman and Hispanic senator. Her work ethic is reflected not only in her 100 percent career-long voting record, having cast 67,923 consecutive votes, but also in receiving more than 1,100 honors for her legislative, public

service and professional work. Of these, more than 500 are in communication, including 45 from the Press Women of Texas' 2021 Professional Communication contest. She "swept" five categories, earning first, second and third place prizes for her speeches, press releases, advertisements, crisis communication campaigns and page designs. First-place entries advanced to the National

Federation of Press Women's competition, in which Senator Zaffirini won five third place awards and four honorable mentions.

What's more, the Texas Press Association named her a Champion of Transparency for her leadership in promoting open government, including by filing eight priority bills in 2021. "Transparency and accountability are essential



for democratic governance," said Senator Zaffirini, a communication specialist with B.S., M.A. and PhD degrees from The University of Texas at Austin.

Because these standards also apply to the judiciary, she passed legislation requiring the rotation and reporting of court appointments; enacting reforms to the State Commission on Judicial Conduct; and promoting judicial efficiency, transparency and excellence. In

2021 the Judicial Section of the Texas Bar Association named her

"Friend of the Judiciary," and in 2022 she received the Liberty Bell Award, which is bestowed upon the non-lawyer who made the greatest impact on the law, from the Laredo-Webb County Bar Association.
